As of July 31, 2026, the Fund’s aggregate NAV was \$1.4 billion, the fair value of its investment portfolio was \$2.5 billion and it had principal debt outstanding of \$1.1 billion, resulting in a debt-to-equity ratio of approximately 0.83 times.

Additional Commentary

Performance Update

Private credit loan¹ quality for the Fund remains strong based on several key metrics including a weighted-average mark² of 98.4 and zero non-accruals as of July 31, 2026.

In the month of July 2026, the Fund generated net investment income of \$0.21 per share, which fully covered the distribution (\$0.19 per share). NAV declined by a total of (\$0.03) per share predominantly driven by positive income accretion of \$0.02 per share, realized losses of (\$0.16) per share primarily due to the closed restructuring for one broadly syndicated borrower³, and unrealized gains of \$0.11 per share that reversed the earlier unrealized losses on the restructured borrower plus fair value marks on the Fund's interest rate swap⁴ and loan portfolio as part of the regular monthly valuation process. The Fund employs an independent third-party valuation process⁵ to incorporate changes in asset performance and market conditions in the Fund's NAV on a monthly basis.

The Fund's year-to-date total net return was 3.78% (Class I)⁶ outperforming leveraged loans by 157 bps⁷ and high yield bonds by 219 bps⁸, and supported by the Fund's modest software exposure, disciplined underwriting, and monthly cash dividend.

Status of Offering

The Fund is currently publicly offering on a continuous basis up to \$4.0 billion in Shares (the "Offering"). The following table lists the Shares and total consideration for the Offering and the Private Offering as of the date of this filing (through the August 1, 2026 subscription date). The Fund intends to continue selling Shares in the Offering and the Private Offering on a monthly basis.

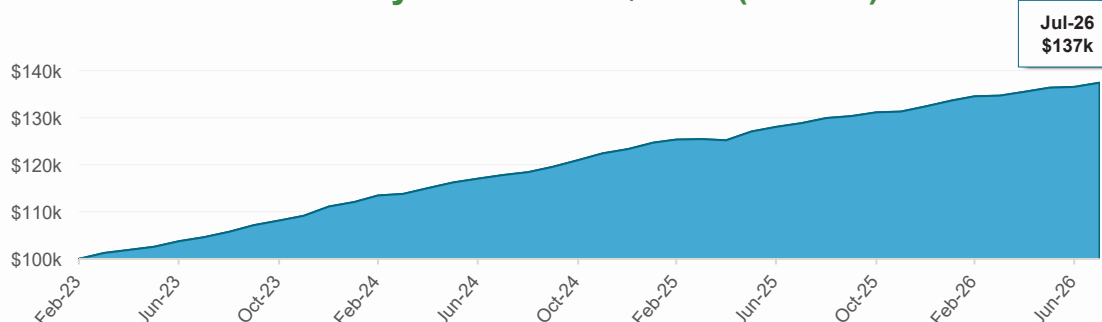

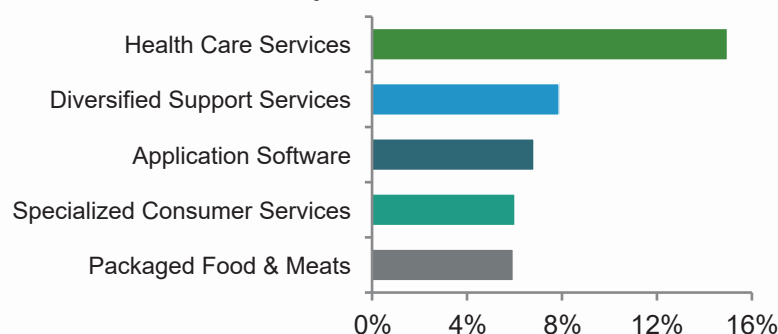
